Discussion: Superintendent, Eric Runez, and Director of Instructional Services, Rebecca Toetz provided an update on the Return to School planning in light of recent changes to Public Health Madison Dane County school guidance. Runez provided an update on the revised PHMDC guidance. Toetz presented planning for phasing in grades 3-12 to in-person learning. Schedules will begin to be more restrictive to make sure staff and students are in compliance with the safety protocols and expectations as part of the transition, with the plan to become less restrictive as time goes on. A tentative phasing in timeline was shared, beginning the week of January 25 but more work will be done on the plan based on Board feedback. Administration will bring a revised Return to School Plan recommendation on January 11, 2021.
